POLICY:

Under certain circumstances, failing grades earned by a student when previously enrolled at Cecil College may be reviewed and designated in such a way as not to be calculated in the student's overall GPA. This policy applies only to courses taken at Cecil College and only to students currently enrolled at this institution.

PROCEDURE:

Academic Senate and the appropriate Senate Standing Committee will review and provide feedback on this policy/procedure every three years or as needed.

All applications must begin with and be approved by an academic advisor. The review of failing grades will be conducted on a course-by-course basis, based on the attached criteria. The student must not have attended Cecil College for at least 1 full semester after failing grades were made and must have earned at least 15 credits of college-level work at Cecil College or any other accredited degree-granting institution prior to requesting a formal review. These credits must have been earned by the student after the failing grades were earned. In addition, the student must have received no grade below a "C" in the most recent fifteen credits earned. In no case will Cecil College waive more than a total of fifteen credits of prior failing grades for an individual. Waiver does not apply to courses that have been repeated and passed.

Applications approved by the advisor will be forwarded to the Registrar.

Grades waived will be identified on the transcript by the letter "V" which indicates they will not be calculated in the student's overall GPA.

This policy does not affect the student's responsibility to meet all program requirements.
