Dr. Bolt participated in the Cecil County Economic Development Commission meeting, Northern Maryland Technical Council, Local Development Council Meeting, Maryland Council of Community College Presidents, Maryland Association of Community Colleges legislative committee, Local Management Board meeting, and the Workforce Investment Board.

Dr. Bolt provided a welcome to the 3<sup>rd</sup> Annual agricultural symposium titled 'Rooted in our Community,' hosted on the North East campus.

Dr. Bolt provided a welcome to the Cecil College Alumni event hosted by the Foundation and held in the Milburn Stone Theatre. As part of the evening's event, guests were treated to a dress rehearsal of Godspell.

Dr. Bolt attended District 36 night in Annapolis along with Dr. Dryer and Brandon Brice. They had an opportunity to thank legislators for their continued support of Cecil College and Maryland's community colleges.

Dr. Bolt attended the Army Alliance Annual Luncheon meeting hosted at Water's Edge. An update was provided on current and future activities planned at Aberdeen Proving Ground.

Dr. Bolt attended the Bainbridge Development Corporation open house and board meeting. She also toured the property along with a sneak peek into one of the warehouses on the property.

Dr. Bolt participated in the Cecil Leadership Institute Day hosted on campus and provided a brief overview of the work at Cecil College. Dr. Joyce presented as well and the entire executive team

was introduced to the group of Cecil County leaders. The student panel was the star of the day as the participants enjoyed hearing from students and they enjoyed a student led campus tour.

Dr. Bolt provided a welcome to the Agriculture Advisory Board meeting. This advisory board meets and discusses curriculum and programs related to agriculture.

Dr. Bolt attended the Association of Community College Trustees Robert's Rules workshop with Connie Deford, professional parliamentarian. This was a Zoom presentation.

#### **RESOLUTION NO: 23-018 APPROVAL OF RECRUITMENT POLICY**

Cecil College recruits and hires faculty and staff on the basis of job-related selection criteria, demonstrated ability, experience, and training. Cecil College is committed to employing qualified individuals without regard to race, color, religion, sex, age, national origin, marital status, sexual orientation, gender identity, genetic information, disability, veteran status, or any other characteristic protected by federal, state, and/or local law.

In furtherance of this policy, all vacant positions will be posted internally and externally. A Division Head who would like to waive a full-time posting and/or post the position as an internal posting only, must submit a memo to Human Resources, explaining the rationale for the request. In collaboration with the Division Head, Human Resources may waive a full-time posting requirement and/or permit a position to be advertised internally after review of current full- or part-time employees or otherwise qualified applicants who possess the requisite skills, qualifications, and academic credentials for the position.

The recruitment, selection, and appointment of individuals for employment at Cecil College are carried out through governance between the President, Division Heads, Search Committees, and Human Resources. The Division Heads, Search Committees, and Human Resources provide advice and recommendations to the President. The final decision with respect to the appointment of a college employee rests with the President. The candidates chosen by the President are subject to approval by the Board of Trustees.

## **RESOLUTION NO: 23-020 APPROVAL OF ADMISSION OF GIFTED AND TALENTED STUDENT'S POLICY**

Students under the age of 16 who have been identified as gifted and talented by the Director of Admissions or the Director of Early College and have a minimum GPA of 3.0 will be allowed to enroll in programs or credit courses at Cecil College where it has been determined that the student is academically prepared and will benefit from enrollment in college-level courses.

The proposed policy has been reviewed by the College Management Team, and recommended to the President. Now, therefore, be it:

RESOLVED, that the Board of Trustees adopts the Admission of Gifted and Talented Students to become effective March 30, 2023.

## **RESOLUTION NO: 23-021 APPROVAL OF PRIORITY REGISTRATION POLICY**

In accordance with the Code of Maryland Article – Education §15–124: Priority course registration for eligible service member.

Eligible service member means:

- 1. A currently serving member of any branch of the armed forces of the United States, including the National Guard and the military reserves; and
- 2. A veteran of any branch of the armed forces of the United States, including the National Guard and the military reserves, who has received an honorable discharge or a certificate of satisfactory completion of military service.

Cecil College grants priority course registration to currently serving service members, and veterans of the armed forces of the United States.

This policy applies only within 15 years after the eligible service member was last on active duty; and does not apply after an eligible service member's fourth academic year

The proposed policy has been reviewed by the College Management Team, and recommended to the President. Now, therefore, be it:

RESOLVED, that the Board of Trustees adopts the Priority Registration Policy to become effective March 30, 2023.
